Frequently Asked Questions (FAQ)

1. What is Eco Club?

Eco Club is a scheme launched by Environment Department under Delhi Government to provide the funds to government affiliated institutions to organise activities and awareness programs related to environment.

2. What is role of Eco – club?

To create environmental awareness among the students of school & college for environmental improvement, to inculcate culture of eco-friendliness and environmental conservation among them.

3. How much grant is provided under Eco- Club Scheme?

Rs. 20,000/- annually

4. Is grant given as per Calendar year or financial year?

Financial year

5. What type of activities done under Eco Club?

Awareness activities through Eco-Clubs:-

- To create environmental awareness among the school & college students for environmental improvement and to inculcate the culture of eco-friendliness and environmental conservation among them.
- To conduct various Environment Campaigns involving various schools & Colleges.
- Various Competitions at State/ School / College level to be conducted including poster competition, quizzes, etc. and organizing Annual Eco-Meet and Vacation Programme for students
- To create awareness regarding Yamuna pollution, its cleaning and rejuvenation among students: visit to water bodies/ rain water harvesting structures/ biodiversity parks. Practicing water conservation activities.
- Organizing Eco-meet by the department. To involve participation of students in various environment related activities such as construction of compost pits, segregation of waste, tree plantation, carrying out tree

census, preparation of biodiversity index in schools and colleges and immediate neighbourhoods.

6. Who can apply or establish Eco-Clubs?

By Government/ Aided, Public Schools and Colleges of NCT of Delhi.

7. How to apply for Eco Club.

Government, Aided, Public Schools and Colleges of NCT of Delhi can apply on Department of Environment GNCTD website.

8. Documents required.

- Utilisation certificate (Performa on Website)
- Cancelled cheque
- Pre receipt form (Performa on Website)
- Annual Report

9. What is Utilization Certificate?

Utilisation certificate (UC) is a document which needs to be submitted at the time of application, which indicates that applicant has utilised the grant provided to them.

10. Is Action Taken Report (ATR) necessary?

Yes, ATR is required after completion of Activity/Event/Awareness activity in addition to the annual report.
